Free Disposal for Acceptable Electronics Only:
Computers (PC), Laptops, Cell Phones

Free Disposal for Acceptable Appliance Items:
Air Conditioners, Microwaves, and Dehumidifiers

CASH Disposal Fee for

ALL TVs and ALL Monitors

\$35 for each TV and \$10 for each Monitor
(no broken glass or disassembled materials accepted)

What *will NOT* be accepted ?

Alkaline or rechargeable batteries, ammunition, compressed gas cylinders, latex paint, medications / unused drugs, sharps, radioactive materials, waste items from businesses or institutions, electronics & appliances not listed above, and any broken glass or disassembled materials.
